2009 Dues Are Now Due

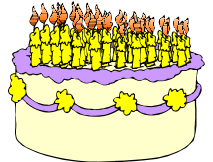
If you have not remitted your payment of dues for 2009, we urge you to do so, promptly. Our calendar year is January through December; therefore, dues for 2009 are due now.

Articles That May Be Of Interest

The following two articles are contributed by Carol Hansing living in California. She does quite a bit of family research in the Kansas area. I hope she is not being hurt by the forest fires. Thank You Carol for the articles.

From the Wamego Times; Present Day.

This article first appeared in the Wamego Reporter of July 19, 1934. It concerns 3.2 beer, which is all Kansas sells outside of state run liquor stores. Jackson County, Kansas is Northeast Kansas.

“Because Jackson County officials hold to a tight laced policy of crusading that looks like any infringement on the state liquor laws, the annual Catholic picnic at Delia is to be moved into Shawnee County. The Rev. J. Towmey has taken charge of affairs connected with the big picnic event and members of his flock who wish some temporary relief from the heat will find it at the picnic grounds four miles east of Delia where, good dependable soft beer will be on tap. The Rev. Towmey applied to the Jackson County officials for permission to relieve the heat situation by providing some of this new style white collar stuff. The state supreme court has said there was nothing illegal about setting the three period two brew unless there was some evidence showing the consumer was confused in understanding the traffic signals. But up in Jackson County beer is beer and this mathematical plan doesn't appeal to the county officials in the least. So the county is

going through the summer on creek water and if some germs get into the systems of the a citizen and taxpayer, he will simply have to see the doctor about that.”

From The Kansas Agriculturist, September 2, 1909.

“There is a superstition to the effect that a sneeze before breakfast indicates that you will receive money before the week is out. A sneeze on Sunday indicates that you have a good excuse for not attending church. To sneeze early Monday morning indicates bad luck. Tuesday indicates more bad luck. To sneeze all day Wednesday means worse luck than on Tuesday. To sneeze on Thursday indicates no change in your luck, and if you should sneeze the greater part of Friday and Saturday it means that you are in a class with the editor, William H. Simmons and many others, and have the hay fever.”

Then we have the next two:

From the Oskaloosa Independent
Thursday, September 30, 1875, Page 3.

“Girls, whatever other folly you may commit, don’t flirt with strangers on the street!! Such a habit is full of danger and often ruinous in its consequences. In most cases the practice is indulged in out of a spirit of fun, but the evil-disposed put the worst construction possible on such conduct, a construction which, if known to you, would shock and horrify. Again we say, don’t flirt, girls.!!”

From the Arkalon News, Front Page, Wednesday, April 15, 1890; Seward County, Kansas.

The habit of gum chewing in this country is producing a race of hollow-cheeked young women. The constant exercise of the masseter muscle hardens it and removes the fatty covering that produces the roundness. Not only is the fullness of the cheek destroyed but there is a tendency to wrinkling of the skin, a natural result to the falling away of the parts beneath it.—Stewartsville, Ind.

How Organized are You?

The ultimate goal of most genealogists is to locate as much information as possible about their ancestors. The research process generates paperwork. You long term success will depend on organizing this accumulated

information into a readily accessible format. At one of the seminars I attended given by Sharon DeBartolo Carmack, who is regarded as one of the foremost authorities on the topic of organization, she stated that if it takes you more than one minute to find a specific document or source, your methods need improvement.

The following questions listed below may help you determine the effectiveness of your organizational abilities:

1. Do you know exactly what information you have for each ancestor?
2. Do you have a complete list of information you are missing for each ancestor?
3. Do you know exactly what resources you've checked, and what results you found?
4. Do you know every book you've ever searched?
5. Do you remember whom you've contacted and what response you received?
6. Can you locate a specific piece of information in your files in one minute or less?

If you answered yes to the questions above, consider yourself above average. If you are with the majority of genealogists who feel their information is all over the place take comfort from the fact that you are in good company. To be successful in genealogical research, one must have the ability to plan each research step and organize the information you find. Taking the time to organize the results of your research allows you to focus on specific research goals. Organized results allow you to evaluate and analyze information quicker and more thoroughly, freeing your time for more research.

As the research process expands from home sources, the amount of accumulated information you must analyze will also increase. Clues found in multiple types of primary and secondary records, indexes, and sources must be investigated. This investigation process will lead through a variety of political jurisdictions, social and religious institutions and organizations, employers, and educational resources.
