2021 Dues It's That Time Again!

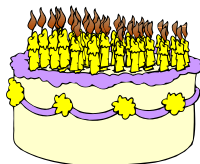

Did you know that in the 1700s & 1800s in America, if a woman's husband died, she was sometimes appointed a guardian to conduct her affairs & that guardian could be her oldest son? Remember that women had few legal rights then and we followed English Common Law in most places in America.

Also, minor children were appointed guardians if they inherited property even if one parent was still alive. Inheritance could include such things as houses, land, and even horses or a feather bed.

These important records (dockets, bonds & record books) can reveal the names of parents, grandparents & other relatives & may even give the birth dates of the children. You will not find them online...you need to contact the local courthouse where you found your family. Be persistent, look at the web page for the courthouse to see what kinds of records they have & who to contact.

Mother's Day 2021

The celebration of Mother's Day allows us to reflect on who we want to be as a family and how we're all connected to one another. Whether it's your mom, grandma, a favorite aunt, teacher, or friend, the women in our lives shape and define us in ways both large and small. Our ability to connect with the world around us begins with our connection to mom.

Mother's Day is also a perfect opportunity to talk about her family memories. What questions could you ask her related to life experiences and memories? If you are a mom, what could you share? Many researchers tend to plan their questioning strategies around the theme of feelings not just facts.

Genealogists can always research names and dates and events. Unless you are lucky enough to discover a diary belonging to your mother or grandmother, the process of researching the "why" behind some of life decisions is difficult. Examples of this type of challenge would include questions such as how they felt when their husband proposed, when their first child was born, when their mother died (how did they cope?), when various historical events happened, etc.

The concept of oral history can be critical to research success. There is no substitute for hearing the facts directly from your mother or grandmother. If they are deceased there are other potential options. Two examples of potential options include if she had a sister, a very close friend, or grown children of a friend or sibling that remember first hand experiences with your mother or grandmother or secondhand stories from their parents. Asking family members about the feelings they experienced around specific events helps us get to know them on a more personal level. It's a benefit of interviewing that you just can't get when you are only researching facts.

Questions can cover many different subjects.

1. What were their favorite foods? Your questions could cover anything from foods prepared for holidays to the everyday. For those with family members who lived during World War II, you can

ask what foods they ate and how rationing affected their families.

2. Many mothers at one time or another worked in some aspect of the food industry. If that applies to your situation, ask them about their work and their day-to-day tasks. One patron many years ago lamented that she wished she learned about this fact sooner so she could have asked her great-grandmother about working as a chef in restaurant kitchens, especially since very few women achieved positions of this nature.

3. Go through the Family Photo Album. For many mothers and grandmothers, one of their greatest wishes and sources of happiness is when their grandkids ask to look at the family photos and wanted to know who everyone was. Mother's Day is a great day, while you have everyone's undivided attention, to break out the photo albums. Use the day to identify ancestors in photos, and tell stories about the event the photo was taken at or where it was taken. Let your family know what you know about those familiar to you but not known to the younger generation. If you don't say something, those deceased ancestors won't be remembered. One way to get your family interested in family history is to share photos.

4. Some additional questions that can be conversation starters include the following:

- a. Tell me about your childhood (toys, friends, sibling relationships, chores).
- b. Who was the oldest relative you knew? Describe that person. What were they like?
- c. Did you know your grandparents? Tell me about them.
- d. Describe living through a historical event or disaster (i.e. the Great Depression, WWII, a big earthquake, assassination of President Kennedy).
- e. What was it like to come to America (if she was an immigrant)?
- f. What was life like in the country you grew up in (if she was an immigrant)?
- g. Who was your first celebrity crush?
- h. What advice would you give to your 16-year-old self?
- i. What did you learn later in life that you wished you'd realized/learned much earlier?
- j. If you had your life to live over again, what would you do differently?

1950 U. S. Federal Census – Obtaining the Enumeration District Number

We've been looking at ways in which to get ready for the release of the 1950 census on 1 Apr 2022. The census will not be indexed on the day it is released; it may be many months before that is accomplished. How will you find those ancestors (or yourself) that you are looking for? You will need to look for the address. Now is the time to prepare for that scenario.

First, make a list of your ancestors' names and their addresses. You might find those addresses by:

- ✓ looking at where they lived on the 1940 census
- ✓ looking the family up in the city directory (if one is available)
- ✓ checking for any letters from that time period with an address on it
- ✓ checking for any ancestors that might have been in the WW2 draft and what address was given
- ✓ checking any birth, marriage, and death certificates from that time period for an address
- ✓ checking for any old address books

Next, you will need to check those addresses to see if they are still viable for the 1950 census and what the enumeration district number will be.

You can then look at the Stephen P Morse One-Step Website Unified Census ED Finder for 1950 (<https://stevemorse.org/census/unified.html>) and locate the ED number for the 1950 census. They have done that hard part for you!

In the panel on the left on the website home page (<https://stevemorse.org/>), under "Census", there are many wonderful resources. One of them is a paper on "Getting Ready for the 1950 Census" (<https://stevemorse.org/census/1950census.htm>) that provides even more information and resources.

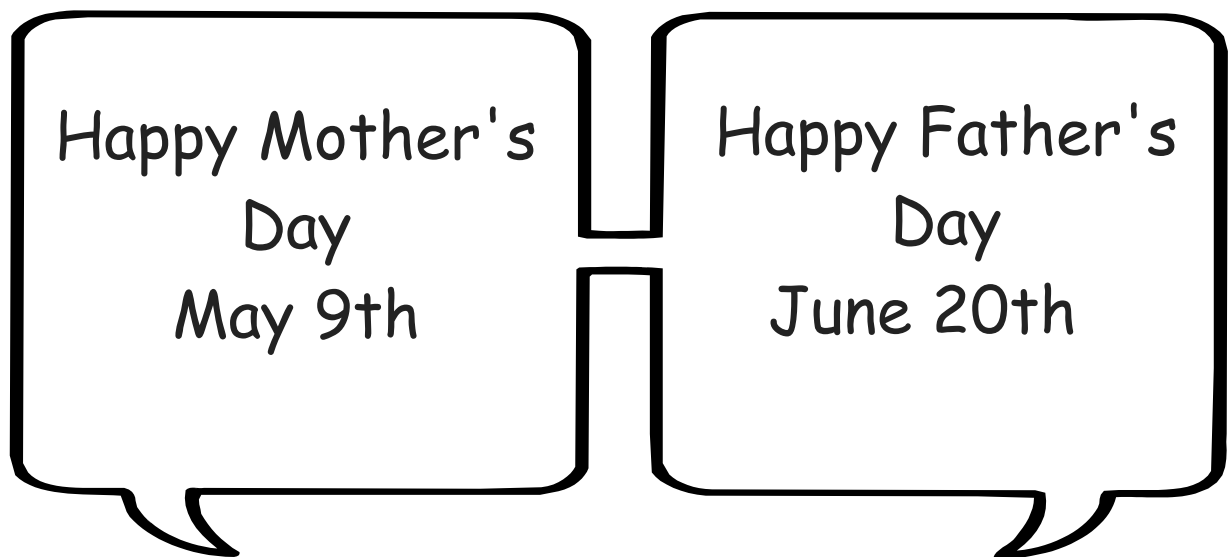
